The GA@ application is maintained and updated on a secure server by Global Payments. It uses a powerful search engine to locate a specific transaction or set of transactions and allows customers to:

- Research and reconcile transaction and settlement information
- Confirm ACH transfers
- Obtain statement information
- Track returned checks
- Review historical chargeback notifications with return reason codes
- Manage historical media retrievals
- Print pre-formatted reports
- Export and manipulate data in preferred format

- Downgrade reason descriptions
